4-4-2 Live Fingerprint Scanner Specifications

Mandatory Requirements:-

2. Must provide fingerprint images in 500dpi or above resolution
3. Scanning time must be less than 2 seconds in automatic mode
4. Must provide fingerprint images in WSQ format
5. Must provide templates in ISO 19794-2/4 format, or ANSI/INCITS 378/381 format
6. Provides automatic capturing mode
7. Provides real time quality of captured finger-prints using NIST quality criteria i.e. NFIQ 1 and NFIQ 2
8. Provides automatic segmentation of four finger slap image and two thumb images into discrete single finger images
9. Provides real time fingerprint image quality checking with support to handle damaged, bandaged or amputated fingers
10. Allows specific finger skipping in multiple fingers capturing mode
11. Support for auto capture on slap/fingers placement as well as manual mode
12. MTBF must be more than 50,000 hours
